

## MAPLE PARK VEHICLE OWNER

To all Maple Park Vehicle Owners, that have vehicles owned, stored, housed or operated within the corporate limits of Maple Park are taxed. The only exemptions are motorcycles, motorbikes and motor scooters.

Fees are as follows: Passenger vehicle \$25.00, Motor Homes \$25.00, Motor Vehicle for Hire (limit 7 passengers) \$25.00, Motorcycles, motorbikes, motor scooters -0-, Trucks Class B through Class F (0 to 16,000 lbs.) \$25.00, Class G through Class Z (over 16,000 lbs.) \$50.00, Semi-Tractors \$50.00, Transfer Sticker -0-, Dealer Plates \$25.00 per plate (maximum of \$150.00 regardless of vehicles), businesses that have their principal business location within the Village shall not be required to pay more than \$200.00 regardless of the number of vehicles owned and/or operated. This does not include personal use vehicles.

The following motor vehicles are exempt: motorcycles, motorbikes, motor scooters, vehicles owned, leased, and operated by the Village, vehicles licensed by the Secretary of State possessing antique vehicle plates or handicapped vehicle plates.

Vehicle sticker (s) may be purchased from the Village Clerk at 302 Willow Street during the following hours: Monday through Friday 7:30 A.M. until 5:00 P.M. Vehicle stickers may also be purchased by mail, if the attached application is filled out correctly and the correct fees accompany the application, **along with a self-addressed stamped envelope**, your sticker (s) will be mailed to your household. Applications along with the fee may also be placed in the Village drop box located at the entrance of the Civic Center.

Vehicle stickers must be displayed on the left quadrant (driver's side) of the front windshield, to be readily readable at all times. Failure to display the vehicle sticker (s) by June 1, 2009 will result in the purchase of another sticker plus late fee per ordinance. Late fees are assessed as follows after June 1, 2009 – late fee of \$10.00 will be added to the fees charged after July 1, 2009 - late fee of \$25.00 will be added to the fees charged. After August 1, 2009, the Village will initiate legal proceedings to collect said fee and late charges.

The Maple Park Police has been instructed to pursue violators to the fullest extent.
